To help expedite the claim process, please complete the claim form in its entirety and include the below information when applicable. This information can be obtained using your online medical portal or by contacting your provider, and can be sent to Cigna at SuppHealthClaims@Cigna.com or by logging into myCigna.com and uploading. Please note we are dependent on receiving this information in a timely manner, otherwise it will delay the payment of any benefits.
