If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care , Office visits subject to a copayment , Prescription drugs subject to a copayment , Urgent care visits and eye exam/glasses for children are covered before you meet your deductible .
