What is the overall deductible ?	\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; or \$3,500 person/\$7,000 family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care and eye exam/glasses for children are covered before you meet your deductible . Office visits, Prescription drugs , and Urgent care visits are subject to a copayment .	This plan covers some items and services even if you haven't yet met the deductible amount.
