More generics and low-cost brands to help you stay healthy and save money

When it comes to prescription medications, you and your doctor usually have a choice between brand name and generic medications. Generic medications offer the same strength and active ingredients as the brand name – but often cost much less – in some cases, up to 80-85% less¹.

Your prescription drug list

Starting January 1, 2016, you'll be moving from the Standard Prescription Drug List to the Value Prescription Drug List. Your new drug list will feature more generic and low-cost brand medications. You may also notice a difference in what tier your medication is listed.

Medications where you will pay more under your plan

You may be taking a medication that's currently considered preferred brand, but will be considered non-preferred brand as of January 1, 2016. This means that for certain brand name medications, your costs will be higher under your plan. These medications include, but are not limited to:

Medications not covered on your drug list

Your drug list will not cover medications in two drug classes that have over-the-counter (OTC) alternatives (medications available without a prescription). These include:

- › Medications used to treat stomach acid conditions (ex. Nexium, Prilosec, Zantac and any generics), and
- › Medications (non-sedating antihistamines) to treat allergies (ex. Allegra, Clarinex, Xyzal and any generics).

Additionally, starting January 1, 2016, several brand name medications will no longer be covered on your prescription drug list.^ This means that if you continue to fill a prescription for one of these medications, you'll have to pay the full cost of the medication.

What these changes mean for you

Starting January 1, 2016:

- ▶ If you're taking a medication that's moving from preferred brand to non-preferred brand, you **will pay more under your plan**. You should talk with your doctor to find out which one of the covered generic or preferred brand alternatives will work for you.
- ▶ If you're taking a medication that's **no longer covered on your drug list**, you should talk with your doctor to find out which generic or preferred brand alternative will work for you. If your doctor feels the alternative medications listed above aren't right for you, he or she can ask Cigna to consider approving coverage of your medication.
If you continue to fill a prescription for a medication that's no longer covered, you'll have to pay the full cost of the medication.
- ▶ If you're taking a medication that's **no longer covered because the drug class isn't included in your drug list**, you should talk with your doctor to find out which over-the-counter alternative will work for you. If you continue to fill a prescription for a medication that's no longer covered, you'll have to pay the full cost of the medication.
- ▶ You can also use the Prescription Drug Price Quote tool on **myCigna.com** to find out if these changes affect the cost of your medication.
