# Q. When can I spend my quarterly allowance?

  - Save up your allowances to order higher priced items later in the year
  - Order once a month up to 12 times a year

Unused balances roll forward each quarter. However, balances do not carry over to the next year.

# Q: Who can get items through my OTC benefit?
