If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , office visits, <u>Prescription drugs</u> , <u>Urgent care</u> visits subject to a <u>copayment</u> and eye exam/glasses for children are covered before you meet your <u>deductible</u> . 
