At Cigna, we work with you to find the right health insurance and help you get the most value from your plan. If you live in the **Denver or Boulder** area, we have a health plan that may be right for you. We offer Cigna Connect plans in the following counties: **Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas and Jefferson.**





All of our plans in Colorado offer:

- › \$0 annual check-up, flu shot, cholesterol and blood pressure screenings.<sup>1</sup>
- › \$0 Telehealth visits so you can talk to a board-certified doctor about minor health issues no matter where you are in the United States, anytime – day or night.<sup>2</sup>
- › A variety of in-network options for you to get care that can save you time and money.
- › Access to customer service and our Health Information Line, 24/7/365.
- › Financial assistance to help lower your monthly premium and/or out-of-pocket expenses, if you qualify.
- › Discounts toward gym memberships, vision exams and eyewear.

**Let’s take a look at some important items to think about when choosing a Cigna health plan.**

**1. Understand costs.**

When researching a health plan, the first thing you should do is review costs so you choose a plan that meets your monthly and overall budget. Cigna offers plans with a range of deductibles, so you can find the plan that best meets your needs. There are different kinds of costs you should understand, including premiums, coinsurance, deductibles, and copays.

|  | <p><b>The health plan premium</b> is a regular monthly payment you make to your insurance company. It’s what you pay to buy your plan and keep your coverage.</p>  |  | <p><b>An annual deductible</b> is the amount you pay for covered medical services or prescriptions before your insurance plan starts to pay.</p>  |
|  | <p><b>Coinsurance</b> is the percentage you pay for covered medical services or prescriptions once you’ve met your annual deductible. Think of it as your share of the costs. For example, after you reach your annual deductible your health plan might pay 80% of a covered medical service. Your share or coinsurance is the other 20%.</p> |  | <p><b>A copay</b> is the fixed amount you pay for a doctor’s visit, prescription or other medical services. Typically, if you have a copay for a specific service you won’t also pay coinsurance.</p> |

## 2. Know the plan's network.

When choosing a plan, you should know how the plan's network operates and the area that it covers. The Cigna Connect Network is an Exclusive Provider Organization (EPO), which gives you access to local providers selected with cost and quality in mind.

### › What is the difference between an in-network and out-of-network provider?

To help you save money, most plans provide access to a network of providers and facilities.

To be a part of the plan's network, these doctors and facilities must meet certain requirements and agree to accept a discounted rate for covered services under your plan. These health care providers are considered "in-network."

If a provider or facility is not contracted with your health plan, they are considered "out-of-network" and can charge you up to full price for services.

**Remember, staying in-network is important to get the most value from your plan. Keep in mind that Cigna Connect plans do not include out-of-network coverage, except in case of emergency as defined by the plan.**



## 3. Understand how your plan works.

Knowing how different plans work is important when choosing a plan.

### › Does the plan require a primary care provider (PCP)?

Yes, Cigna Connect plans require a PCP to be a part of your care team. Your PCP acts as a team leader who can help keep you healthy by coordinating your care. This is the person to go to for routine care and to get a referral to see a specialist.<sup>4</sup> Your PCP will refer you to in-network options for care, which can save you money. In most cases, a PCP will automatically be assigned to you.<sup>5</sup> If you prefer a different PCP, you can easily change your PCP after your plan starts. Whether you already have a PCP, or if you're choosing a new one, please remember to check to make sure they're in-network – so you can get the most value out of your plan.

### › Do you already have a PCP?

We understand the relationship with your PCP is important to you. You can find out if your PCP is in the Connect Network by visiting [Cigna.com/ifp-providers](https://www.cigna.com/ifp-providers). You can select this provider as your PCP after your plan starts.

### › How can you access care if your PCP isn't available?

If your PCP is not available, you can still access quality care by visiting an in-network urgent care center, convenience care clinic, or using Cigna Telehealth Connection. Of course, for a true emergency<sup>6</sup> you can access an emergency room (ER) 24/7 both in- and out-of-network.<sup>7</sup>

4. Females can obtain services for obstetrical or gynecological care from a participating provider without a referral from their PCP. See plan documents for this and other exceptions to the referral process.

5. For children, you may select a participating pediatrician as the PCP. See plan documents for more information on selecting a PCP.

6. Emergency medical condition as defined by the plan

7. Eligible out-of-network emergency services are covered at the in-network benefit level as defined in plan documents.

› **Can you access care online or on the phone?**

Telehealth benefits, through Cigna Telehealth Connection, are available for minor acute care by phone or via secure video chat anywhere in the U.S., 24/7/365.<sup>2</sup>

› **How can I get more information about prescription drugs?**

Before deciding on a health plan, search for your prescription drugs to make sure they will be covered under the plan. You can find a prescription drug list by visiting [Cigna.com/ifp-drug-list](https://www.cigna.com/ifp-drug-list).

**4. Consider financial assistance on Connect for Health Colorado.**

If you qualify, there are two forms of federal financial assistance available when buying a plan on Connect for Health Colorado.



**Premium tax credits** can reduce your monthly premium payments when you enroll in a Qualified Health Plan (QHP).<sup>8</sup> You can apply all, or a part, of this tax credit to your premium to lower your monthly bill.

Premium tax credit eligibility is based on household size and income. Individuals earning up to \$49,960, or a family of four earning up to \$103,000, may be eligible.<sup>9</sup>



**Cost-sharing reductions**<sup>10</sup> can reduce the amount you pay out of pocket when you get care. These include deductibles, copays or coinsurance. Household size and income requirements determine the amount of the reductions. Cost-sharing reductions may be available along with the premium tax credit.

To get these savings, you must enroll in a Silver QHP plan. Individuals earning less than approximately \$31,225 or a family of four earning up to approximately \$64,375 may be eligible.

**Financial help is not available if:**

- › You are eligible for affordable minimum-value, employer-sponsored coverage (whether you enroll or not) .
- › You are covered under an employer-sponsored group health plan.
- › You qualify for Medicare or Medicaid coverage.

**Native Americans and Alaska Natives may qualify for tax credits and special cost-sharing reductions if specific requirements are met.**

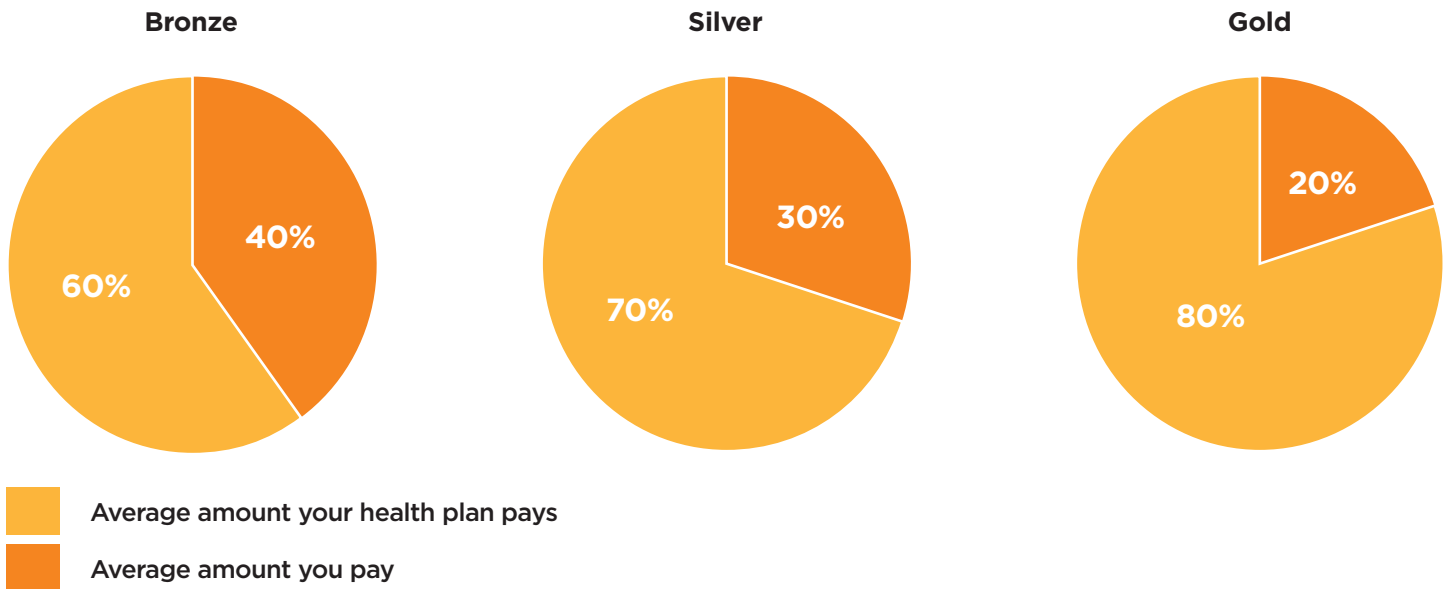
8. Federal financial assistance can only be applied to the purchase of a QHP.

10. Customers must select a Silver QHP to take advantage of cost-sharing reductions. Cost-sharing reductions are calculated online, based on your household's eligibility for federal financial assistance.

### 5. What the “metal levels” mean.

Bronze, Silver and Gold are some of the different categories, or metal levels, of plan coverage you’ll see on Connect for Health Colorado. Plans in each category pay different amounts of the total costs of an average person’s care. This includes deductibles, copays, coinsurance and out-of-pocket maximums. Generally, the higher the metal level, the more expenses your plan covers. The actual percentage you’ll pay in total will depend on the services you use during the year.

Medical plan rates vary based on plan design, age, family size, geographic location (residential zip code) and tobacco use.

Rates for new medical policies/service agreements with an effective date on or after 01/01/2020 are guaranteed through 12/31/2020. Thereafter, medical rates are subject to change upon 60 days prior notice.

Insurance policies/service agreements have exclusions, limitations, reduction of benefits and terms under which the policies/service agreements may be continued in force or discontinued. Medical applications are accepted during the annual Open Enrollment Period, or within 60 calendar days of a qualifying life event. Benefits are provided only for those services that are medically necessary as defined in the policy/service agreement and for which the insured person has benefits.

You may cancel the policy/service agreement on the first of the month following our receipt of your written notice. We reserve the right to modify the policy/service agreement, including plan provisions, benefits and coverages, consistent with state or federal law. Policies/service agreements renew on a calendar year basis.
